Accreditations are limited. Submission does not guarantee accreditation and all applications will be subject to confirmation.

The Accreditation Pass given with these terms and conditions, and the right of accreditation which comes with it (the "Accreditation"), are personal to the party named on the Accreditation Pass (the "Accredited Party") and nontransferable and must be clearly displayed at all times. The bearer may enter only those areas or facilities (the "Permitted Areas") as designated by the Oceania Football Confederation (OFC) ("OFC") and/or the local organising committee of the OFC U-16 Championship 2018 ("LOC") and displayed on the Accreditation Pass. The Accreditation is for all parties requiring accreditation.

These terms and conditions apply to all Accredited Parties with the exception of sections that are expressly addressed to or that expressly exclude certain Accredited Parties. Accredited Parties to whom special terms and conditions apply are (i) the written press, including editorial internet and mobile sites, and photographers ("Written Press and Photographers"), (ii) OFC's TV-, Radio-, Broadband Internet- and Mobile-Rights Licensees ("Media Rights Licensees"), (iii) and/or audiovisual media organisations, which for the avoidance of doubt include TV, Radio, Broadband Internet and Mobile entities, that are not Media Rights Licensees ("Non Rights Holders").

The Accreditation Pass is the property of the LOC and the rights granted to the Accredited Party by the LOC can be cancelled at any time in the LOC's sole discretion and the Accreditation Pass must be returned to the LOC immediately upon request at any time. By entering any of the Permitted Areas, the Accredited Party agrees: (1) to comply with all rules and regulations of the OFC U-16 Championship 2018 (the "Competition"), in particular those relating to safety and security and OFC's commercial programme; (2) to consent to search and inspection for prohibited items and/or confiscation of prohibited items; (3) to assume all risks incidental to attendance at the Competition and/or other related events controlled by the LOC and/or OFC; (4) not to carry into or wear on the premises controlled by the LOC or OFC any political, religious, racist, promotional or advertising material, signage, objects or messages; (5) to the greatest extent permitted by applicable law, that the LOC, OFC, and/or their licensees may use in perpetuity, for commercial purposes or otherwise, free of charge or any compensation, his/her voice, image, photograph and likeness by means of live or recorded video display, broadcast, streaming or other transmission or recording, photographs or any other current and/or future media technologies (now known or hereinafter invented and/or devised), and irrevocably consents to the use of such voice, image, photograph or likeness by OFC, the LOC and/or their licensees to use such media. The Accredited Party waives in advance all rights and actions seeking to oppose such use, subject to applicable laws. OFC, the LOC and/or their licensees will be bound by, and comply with, all applicable laws with respect to any use they may make of such media; (6) that OFC and/or the LOC or their authorised representatives may refuse entry to the Accredited Party to any of the Permitted Areas for any reasons whatsoever in their absolute discretion; (7) not to offer to sell, sell or possess with intent to sell such goods as drinks, food, souvenirs, clothes, promotional and/or commercial items except if approved in writing by OFC or the LOC; (8) not to sell, offer to sell or otherwise transfer or part ownership of the Accreditation Pass.

**The following applies to all parties EXCEPT the Written Press and Photographers and Media Rights Licensees:**

The Accredited Party may not record or transmit any sound, moving or still image or description of the Competition (or any result, data or statistic of the Competition) other than for private use. It is strictly forbidden to disseminate any sound, moving or still image, description, data, result or statistic of the Competition, in whole or in part, for any sort of public access, irrespective of the transmission form, whether over the internet, radio, television, mobile phone, data accessory or any other current and/or future media (now known or hereinafter invented and/or devised). The Accredited Party may not assist any other person(s) to conduct such activities. The Accredited Party shall not disclose any information that is confidential or private in relation to any third party, including without limitation, information which may compromise the security, staging or organisation of the Competition, or the security and/or the privacy of any third party.

**The following applies ONLY to the Written Press and Photographers:**

Except as expressly permitted in these terms and conditions, the Accredited Party is prohibited from recording and/or transmitting (over any media, including, without limitation, the internet and mobile devices such as mobile telephones and PDA's) any sound (including commentary) and/or image (whether moving or still) of the Competition for any purpose whatsoever or from assisting any other person or entity to do so.

Notwithstanding the above, the Accredited Party may record and/or transmit still photographic images (but NOT any moving images) for publication in or on newspapers, magazines, newspaper or magazine supplements (and any online and/or mobile version of such newspapers, magazines or supplements) and editorial internet and mobile sites, provided that: (1) they appear as still images (and not as moving images or rapid-sequence streaming or images); (2) images are published for bona fide editorial news reporting purposes only and; (3) the transmission of images is made on a secure basis so as to prevent unauthorised access or viewing. No moving image recording equipment may be in any Permitted Area

Condition number (2) in the preceding paragraph does not apply to any Accredited Party insofar as such Accredited Party supplies images to a Photographic Agency (as defined below) or who is itself a Photographic Agency, provided that such images are not then supplied by the Photographic Agency to any further party in contravention of any of the principles outlined in the preceding paragraph. A "Photographic Agency" is a party whose primary business is the sale and/or syndication of photographic images via closed-user group, subscription-based online photographic agency distribution websites for the purposes of commercial image sales, distribution and/or syndication. The Accredited Party shall not engage (either by itself or with any third party) in any marketing, promotions or any other activities associated with the Competition, or use any materials created by the Accredited Party under the Accreditation for such purposes, without the prior written approval of OFC which may be withheld in OFC's absolute discretion.

**The following applies to all Accredited Parties:**

The Accredited Party hereby indemnifies and holds the LOC and OFC harmless from and against all damages and liabilities suffered or incurred in connection with, resulting from or arising out of any breach of these accreditation terms and conditions.

The Accreditation does not give the Accredited Party or any other party the right to obtain a seat at the Competition.
